ORDER APPROVING PRELIMINARY LIST OF MSIC'S ASSETS AND RECOMMENDATION REGARDING ASSETS

Indiana Insurance Commissioner Carol Cutter, in her capacity as Liquidator of Medical Savings Insurance Company ("MSIC"), filed a Preliminary List of MSIC's Assets and Recommendation Regarding Assets ("Preliminary List/Recommendation") on June 26, 2009. Having considered the Preliminary List/Recommendation and being duly advised, the Court determines that the Preliminary List/Recommendation should be granted in all respects:

IT IS, THEREFORE, ORDERED THAT:

1. The Preliminary list of MSIC assets which were submitted as Exhibit A, are accepted by the Court in accordance with Ind. Code 27-9-3-13.
2. The Court further approves the Liquidator's recommendation, submitted in accordance with Ind. Code 27-9-3-32, that the MSIC estate currently does not have possession and control of sufficient assets to make an early access distribution to guaranty associations.
